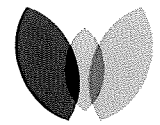
**RECOMMENDATION OF SUPERINTENDENT:**

**DETAILED BACKGROUND:**

This agreement states Washburn Center for Children will provide clinical mental health assessment and therapy, care, coordination and other ancillary services to Bloomington School students outside of the educational model. The services will be provided on school sites and will provide support to the family and home as necessary.

The District's legal counsel and insurance carrier of record have reviewed the agreement.

**CONTRACTUAL AGREEMENT**  
**between**  
**WASHBURN CENTER FOR CHILDREN**  
**and**  
**INDEPENDENT SCHOOL DISTRICT 271**  
**(of Hennepin County)**

This Agreement is between Washburn Center for Children a (501c3) non-profit organization based out of, 1100 Glenwood Avenue, Minneapolis, MN 55405, hereafter referred to as “WCC” and Independent School District 271, Hennepin County, MN, hereafter referred to as “SCHOOL.”

**A. Relationship**

WCC and SCHOOL agree that their relationship is that of independent contractors and not that of employer or principal and agent. This agreement does not designate either as an agent of the other, nor does it designate or imply an employment relationship, partnership, agency or joint venture. This Agreement is not exclusive to either party.

**B. Objective**

The objective of the agreement is to provide clinical mental health assessment and therapy, care coordination, and other ancillary services to Independent School District 271 students outside of the educational model. These services should be available on school sites as defined and provide support to the family and at home as necessary. These services are intended to assist in maintaining educational services for special education students and general education students in the least restrictive environment. They are also intended to provide staff development and consultation to Independent School District 271 staff that will assist them in supporting the students in the educational setting. This service is expected to collaborate and compliment any existing services provided by the licensed staff, psychologists, social workers or counselors but is expected to extend into a clinical therapeutic model which is beyond the “educational provisions” that are in place.

**C. Certification**

WCC represents that it is registered with the State of Minnesota as a CTSS-certified, Rule 29, Community Mental Health Center, and employs therapists who are licensed by and in good standing under the laws of the State of Minnesota.

**D. Scope of Service**

1. WCC will provide full-time licensed mental health professional services at six schools in the Independent School District 271 (Oak Grove, Pond, Westwood, Washburn, Valley View Elementary and Valley View Middle School) during the 2017-2018 School Year. The actual hours/days of service at sites will be determined by WCC staff, supervisors, and appropriate District personnel in order to meet the needs of individual children, families and the District.



Scope of Service (continued)

2. WCC will provide mental health services, including: early identification; consultation to school staff; diagnostic assessment; training; care coordination and treatment.
3. WCC will own all clinical records including testing results, reports and clinical notes generated as a result of client contact. School personnel shall not have access to the records or to information about clients without a signed release of information from the client or client's parent/guardian.
4. WCC will retain any income from commercial health insurance, Medical Assistance or other payers remitted for services of WCC.

E. Payment

WCC will bill the SCHOOL in August 2017 for services to be provided during the 2017-18 school year. The SCHOOL will pay WCC in the amount of \$80,000 per 12 month period (\$13,333.33 per school site) which will be billed to SCHOOL at the end of each month of this contract. Payment will be made monthly by SCHOOL to WCC within 30 days after receipt of bill. Funds are for non-reimbursable program expenses associated with the delivery of non-clinical services (i.e., early identification; program development, consultation to and collaboration with school staff and parents; training; and care coordination).

F. SCHOOL Responsibilities

The SCHOOL will provide office furniture, phone and internet connections, a locked filing cabinet, office supplies, and a private, confidential office space in an appropriate area for therapy.

G. Limited Insurance

WCC will carry liability insurance covering the scope of its services, staff, and facilities in terms of medical malpractice and negligence. WCC agrees to obtain, and maintain, during the Agreement's term, or any extension or renewal thereof, professional liability insurance in the minimum amount of One Million Dollars (\$1,000,000) per occurrence and Three Million Dollars (\$3,000,000) aggregate coverage for any personnel assigned pursuant to this Agreement with Independent School District 271 named as and "additional insured".

H. Confidentiality

WCC will protect and maintain the confidentiality of pupil records and patient health care records, as required by state and federal law. This provision shall continue to be effective after the termination of this Agreement. Upon termination of this Agreement, WCC will maintain all records, documentation, and other items that were used, created, or controlled by WCC during the term of this Agreement.

I. Modification of Contract

No waiver or modification of this Agreement or of any covenant, condition, or limitation herein contained shall be valid unless in writing and duly executed by the party to be charged therewith and no evidence of any waiver or modification shall be offered or received in any proceeding between the parties unless in writing.




J. Termination

This Agreement may be terminated by either party upon a two-month written notice delivered to the other party. Since services are billed at the end of each month no refund will be warranted from WCC to SCHOOL.

K. Period of Agreement

This Agreement shall be in existence for the period of July 1, 2017 through June 30, 2018.
