**RESOLUTION FOR BOARD TO ADOPT:**

RESOLVED, that the School Board of Independent School District 271 approves an agreement with Sunshine Kennels & K9 Training for the sale and training of a certified therapy dog.

**DETAILED BACKGROUND:**

The District will pay Sunshine Kennels \$3,500 for the purchase of Radar, a certified therapy dog, and a minimum of three training sessions for Radar with Oak Grove Middle School Principal Brian Ingemann, who will be the primary handler. The first training session will be in October.

The District's legal counsel and insurance carrier of record have reviewed the agreement.

**AGREEMENT FOR THE SALE AND TRAINING OF A CERTIFIED THERAPY DOG**

The Parties to this Agreement are:

- Sunshine Kennels & K9 Training
- Independent School District No. 271 - Bloomington Public Schools

Sunshine Kennels agrees to sell to Independent School District No. 271 - Bloomington Public Schools:

- A certified therapy dog – named Radar –
  - Radar is a trained therapy dog
  - Radar is a neuter black male Labrador
  - The total purchase price for Radar is \$3,500


Sunshine Kennels agrees to train:

- Principal Brian Ingemann to be Radar's handler
  - Principal Ingemann upon completion of the training will be certified to be Radar's primary handler.
  - Training will begin in October 2017.
  - A minimum of three training sessions will be held at the Sunshine Kennels – Training to be completed no later and December 31, 2017.

Independent School District No. 271 - Bloomington Public Schools agrees to:

- Pay Sunshine Kennels \$3,500 for the purchase of Radar.
- Pay a deposit of \$1,750 within 5 days of both parties signing this agreement.
- Pay the remaining \$1,750 when Principal Brian Ingemann shows up for his first training session in October.
- Make Principal Brian Ingemann available for the needed training.
