RESOLUTION RELATING TO THE NON-RENEWAL OF THE TEACHING CONTRACT OF A
PROBATIONARY TEACHER

RESOLVED, By the School Board of Independent School District No. 271, pursuant to Minnesota Statutes 122A.40, that the teaching contract of Channing Smith, a probationary teacher in Independent School District No. 271, is hereby terminated at the close of the current 2017-2018 school year, June 30, 2018, and is not renewed for the 2018-2019 school year; and be it

RESOLVED further, That the Clerk of the School Board shall issue written notice to said teacher regarding non-renewal of the teacher's contract as provided by law, and that said notice shall be substantially the following form:

NOTICE OF TERMINATION

You are hereby notified that at a regular meeting of the School Board of Independent School District No. 271, held May 14, 2018, a resolution was adopted by a majority roll call vote giving action that your teaching contract will not be renewed effective at the end of the school year, June 30, 2018, and is not renewed for the 2018-2019 school year. Said action of the Board is taken pursuant to M.S. 122A.40.

You may officially request that the School Board give its reason for the non-renewal of your teaching contract. However, such request must be received within ten (10) days after the receipt of this notice.
